CUSTOMS CLEARANCE CHALLENGES

- One of the challenges we faced is the justification of the tariff 8463.30.00 for the nail making machine. This tariff is basically exempted from any taxation. The machine was shipped in different batches thereby making it a challenge to justify the tariff considering its not applicable for a part of the machine.
- However, this was resolved via clearance under bond which we later cancelled after all the shipments had been cleared and customs visited the site during set up


CRANE SERVICES
